What do we stand for?

Introducing and describing the goal and means of the Cyrus Force in the US (Followers of Cyrus in Iran)

Followers of Cyrus have existed in Iran since 2500 years ago. However, 20 years ago, the organization was officially registered in the United States of America under the name of "Cyrus Force" as a non-profit 501(c)(3) Federal Tax ID #46-5635908. Its main objective is to amend and restore Iran's constitution and the Fall of Ayatollah's Regime.

The Followers of Cyrus, whose name is the "Cyrus Force" in America, now have a goal and a means to amend the constitution in Iran and, eventually, the fall of the Ayatollahs' regime, which they have proposed in the attached booklet.

Cyrus Force is not a political party or a special interest group; furthermore, the followers of Cyrus are not looking to collect members and supporters; instead, they offer their road map to the Iranian diaspora and especially Iranian Americans, who, as volunteers with their own name and organization, to continue our strive towards the separation of church and state. We believe nobody should face repression in their quest for freedom.

The Followers of Cyrus offers the booklet describing our goal of social change through a precise process of amending the constitution in Iran in 8 steps. This process is provided to every Iranian diaspora member in their party, group, association, front, or congress, allowing them to examine this method and idea and, if agreed upon, follow the process outlined in the booklet.

It is prudent to know how protests against the Islamic Republic Constitution started how the protests were crushed in different

stages and how the future stages of the protests will lead Iranians to their final goal to change the constitution

The first step (of the eight steps) started in the spring and summer of 1979 in Kurdistan, which was crushed by Ayatollah Khalkhali, and the protest echoed in the Assembly of the Ayatollahs by Ayatollah Taleghani. However, Ayatollah Taleghani was killed on September 25, and consequently, Article 5 (absolute power of the Ayatollah Leader) was inserted in the constitution on September 28. Other articles 57 and 110 later added as the expansion of Article 5.

The green movement of 2009 was step 2 until step 3 in June 2021, Manifestation of 14 People and massacre of the Fall of 2021.

With the death of Mahsa Amini in September 2022 the most significant protest was triggered all over Iran, which is called “Woman Life Freedom Revolution”. This protest, which is an objection to articles 5 and 8 of the constitution, puts Iran at step 4 and has continued up to now and will continue.

Iranian diaspora members, as well as Americans, can implement this method of overthrowing the Ayatollahs' regime within the framework of their party and group and in their name without deviating from their organization's guidelines.

Cyrus Force's proposed amendment to the constitution does not involve rewriting and becoming the author of the new constitution; instead, it contains an 8-step process fully described in the twenty-page booklet.

In the past forty-five years, none of the significant movements and uprisings inside Iran, from the Summer of 1979 Kurdistan Massacre to the 2009 Green Movement, the June 2021 Manifestation of 14 people, and the Fall of 2021 massacre. None of these uprisings have brought a revolution to change the Iranian

constitution or the behavior of the Ayatollahs towards the separation of church and state; however, the recent revolution of The Woman Life Freedom has attracted the world's attention since 2022.

As written in the booklet, the regime of the mullahs is ideal for most of the countries of the world, and especially the World's Military Industrial Complex. No government in the world has ever wanted or shall want to change the mullahs' regime in Iran.

But with the advent of the Women's Life Freedom revolution, many people's consciences have been awakened. The time has come to transition the revolution through the subsequent phases on the unbreakable foundation of the Women's Life Freedom revolution, a protest against Articles 5 and 8 of the Iranian Constitution.

However, in the summer of 2024, to prevent the inevitable fall of the Islamic regime, Ayatollah Khamenei was forced to appoint a moderate and reformist as the interim President against his own will and desire so that he could entertain the Iranian people for a few years like President Khatami's era.

The followers of Cyrus and the Iranian people inside and outside of Iran know quite well that the selection and the appointment of the President in Iran is under the control of the supreme leader which is derived from the constitution. The President does not have full authority to govern over the country's macro policy, restrain theft, looting and support for terrorist groups. He has no meaningful control over his government, hence the Ayatollah's power in creating crises in the world will continue as in the past, but the President and the foreign minister role are to prevent the fall of the regime for a while through their clever, demagogic and disingenuous practice against the people.

In the booklet of the Followers of Cyrus, the process to reach our goal is clearly specified in simple language.

Let's be clear that the Cyrus Force in America has nothing on its agenda other than conveying the message to the US Senate and Congress that amending and restoring Iran's constitution is the only means of changing the behavior of the Ayatollahs and addressing this vital phenomenon until the Fall of Ayatollah's Regime.

Furthermore, the US Congress and Senate have no jurisdiction to put pressure on the Ayatollahs except to enact Smart Sanctions against Iran's Oligarchy looters!

It is necessary to explain that the current US sanctions against Iran are in favor of the government and looters of Iran,

Any product and services of the western countries are available in Iran by circumventing American Sanctions by doubling and tripling prices. The benefits will go directly to the Ayatollahs Oligarchies pockets, whom deposit their profits in the Western banks and at the same time, they have caused enormous financial damages to all sectors of society and most of the noble and defenseless people of Iran.

The two measures are on the agenda of the Cyrus Force of America.

The rationale for writing such letters, guidelines, and sending booklet is because Iranians and Americans can act independently in their own name, and even without any dependency on Cyrus Force, hence, they convey the message of changing and restoring Iran's constitution and the Fall of Ayatollah's Regime to the American politicians.

If the narrative of the Islamic Republic of Iran Constitution and all its anti-American rhetoric are considered and debated by the American Administration and certain smart Sanctions are imposed on the Oligarchies of the Ayatollahs, then the Iranian revolution will enter into the 5th steps.

Other future steps (processes) are in place and understood that are implemented consequently to change the constitution and behavior of the Ayatollahs' regime in Iran.

Steps (processes) 6, 7, and 8 when will be implemented; consequently, the final stage will be to write a new constitution by the representatives of the Iranian People in the “Majles” Parliament in Iran without any outside interference by other governments. The only way to reach this goal is to complete step 5 execution.

This booklet of the Cyrus Force will be published in English and Persian languages.

Preface

This pamphlet is an acknowledgment of the Woman Life Freedom Revolution in Iran.

Neither in the Constitution of the Islamic Republic of Iran (IRI), aka the Ayatollah Constitution, nor in the revolutionary narrative and promises of Ayatollah Khomeini was there any mention of the Hijab or the non-equality of women's rights.

Women in Iran, who were enjoying almost equal rights with men and freedom, gradually had their rights taken away, and protests gradually increased until the death of Mahsa Amini, which triggered the Woman Life Freedom Revolution.

This revolution, which is a protest to Articles 5 and 8 of the Islamic Constitution of Iran, will never disappear despite regime suppression attempts and events outside Iran.

The change of the Constitution in Iran is not any other country's business. Because of specific references in the Constitution to hostility and terrorizing another country and with explicit language to fight and threaten the interests of any other country, henceforth, the other country has the right to defend and protest against those references in the Constitution of the Islamic Republic of Iran (IRI).

Since eight instances in the Islamic Construction of Iran specifically call for hostility, terrorizing, and fighting with the interest of the United States anywhere in the World, the US has the right to question the intent and protest against the Islamic Constitution of Iran.

Meanwhile, the United States has a common ground with the people of Iran, who not only are protesting for the change of the Constitution, but also adore and respect the people of the US. As a result of this situation, the Cyrus Force's mission is to convey this message to the US Congress and the American Government to enable and enforce Smart Sanction(s) against the

Oligarchies of the Ayatollahs who have sleeping cells to enact future terrorist acts against the United States.

Introduction

This pamphlet is a brief statement of Cyrus Force's Road Map for change of Ayatollah's behavior in Iran and the organization's message to Western Administrations and Parliaments, specifically the Senate of the United States of America.

In the interest of brevity, four thousand years of the region's history and Iran's history are not mentioned herein, but to understand Cyrus Force's reasons for the "Change of Constitution in Iran and the Fall of Ayatollah's Regime," it is necessary to display the picture of the Cyrus Cylinder, which was the heart of a genuine constitution governing the region from India to the Mediterranean before the collapse of the Persian Empire fourteen Centuries ago.

"The conflicts of the Middle East will never end as long as the regime of Ayatollahs are in power in Iran," a quote from British Prime Minister Tony Blair when his Quartet Mission failed on May 25, 2015.

Altering the Ayatollah's constitution in Iran, which ultimately changes the regime, is an eight-step process. After the "Woman Life Freedom" revolution in Iran, the fourth step has been entered, as explained in this pamphlet.

It is noteworthy that the two regimes in Iran after the Second World War have dominated the politics of the Middle East and have become a great source of income for the Military Industrial Complex.

The Ayatollah's regime has been favored by the East and the West to remain in power in the past decades by creating crises. These governments have even encouraged the Ayatollah's theft to export the people's assets and deposit the stolen wealth in banks outside of Iran, let alone the profitable brain drain of the Iranians.

Although politicians' primary concerns are the trouble areas of the world, e.g., Ukraine, Gaza, and perhaps the South China Sea, the perplexing character of the Ayatollah's Regime, with its

constitution, has enabled it to influence any trouble spot in the world by fighting against American interests.

Inside Iran, the "Woman Life Freedom" revolution started and will never slow down, end, or be forgotten like other movements in the past.

People inside Iran have no regard for the so-called opposition outside Iran led by the monarchists of the previous regime and Mujaheddin (MKO).

MKO was on the terrorist list of the West for a few decades. In the past four decades, it has been public knowledge that those opposition groups have never been able to help people inside Iran.

Nevertheless, these two popular oppositions outside of Iran have nothing to say or do except relay the news and use public knowledge of the situation in Iran to gain a name for themselves and overshadow the revolution and the freedom movements inside Iran to benefit financially.

The first chapter of this pamphlet is Cyrus Force Road Map for the Change of the Constitution in Iran, the Fall of Ayatollah's Regime, and our typical letters, which have been sent to the US Senators, the White House, and Western politicians.

The second Chapter is about what Cyrus Force is doing in the Western hemisphere.

The Third Chapter is about Cyrus Force's efforts and activities inside Iran, in which the Ayatollah's Regime could not object to enlightening the Iranian people. Included:

- 1- Reading the Persian Chronicle Quran (Quran e Rastin).
- 2-Reading Shahnameh (Epic of the Kings), the most significant Iranian literature.
- 3- Understanding the meaning of Cyrus Cylinder Message and comparing that with the Magna Carta of England.

4- Remembering the three commandments of the Zoroaster.

The fourth chapter is the conclusion.

Chapter One

The Road Map

Message of Cyrus Force

The road map to save Iran, the goal of us, the Americans and the Iranian-Americans

Today, spreading words and writing articles about the history of several thousand years of Iran or the last hundred years, if it can be called the era of modernity and prosperity, will not heal the wounds of today's Iran, which are the looting, betrayals, and crimes of the Mullah's Cult terrorist regime until the destruction of Iran.

The young Iranian generation inside Iran seeks ways to save themselves and reach their goals. It is of particular interest that the Iranian diaspora in the West say and write that it is not essential to them.

Today, the young generation of Iran, who have led the Woman Life Freedom Revolution since late 2022, needs more international help to continue with the revolution and succeed in a reasonable time.

In the fall of 1978, when Khomeini was forcefully immigrated to Paris, twelve intellectual Iranians introduced a constitution to Khomeini that included the separation of religion from the government based on human rights, the freedom of the people and the press, and whatever the exiled political activists of the Shah's era wanted.

Khomeini approved the proposed constitution and promised it would be Iran's future constitution.

Consequently, the first slogan of the 1979 revolution was "Independence, Freedom, Constitution," which later became "Independence, Freedom, Islamic Republic."

Khomeini preached his principles to the people until the day of

the referendum on April 1st, 1979, to remove the Pahlavi regime and establish the Islamic Republic.

In his first speech at Behesht Zahra Cemetery, he said, "Do not be just happy with our small work providing you with free water, electricity, and transportation; rather, be happy because we will build housing for you and even guarantee your future life after death."

After Khomeini's referendum on April 1st, 1979, with the formation of the Mullahs' Assembly of Experts instead of the Constituents Assembly, the regime's natural face was gradually revealed, and the Mullahs started discussing their flavor of the constitution.

The most important principle of "Velayat e Faghih" (absolute power of the Supreme Leader), which Ayatollah Taleghani opposed, caused street protests across Iran. The demonstrations were witnessed more vividly in the City of Sanandaj, Kurdistan, than in any other part of Iran.

Khomeini dispatched all the armed forces to Kurdistan to suppress and crush the protesters.

Ayatollah Khalkhali (known as Ayatollah Butcher) was sent to Kurdistan along with young Ahmadi Nejad (a professional killer) and started mass killings in Kurdistan that cannot be forgotten. In that year, the images of the executions by shooters won the Pulitzer Prize!

In August and early September 1979, Ayatollah Taleghani, protesting the principle of Velayat-e-Faghih, angrily left the Assembly of Experts and migrated to Taleghan's birthplace. Right after returning on the 16th of September 1979, they murdered Ayatollah Taleghani. On the 19th of September, Article 5 of "Velayat e Faghih" was inserted into the constitution by force, hence completing Khomeini's deception.

For 45 years, the followers of Khomeini have stolen more than one thousand billion dollars from Iran's treasury with the direct use of Article 5 of the Constitution and deposited the stolen funds

in foreign banks in the name of mullahs/cronies.

All the industries, mines, government companies, and agricultural companies were confiscated and then registered under the pretext of privatization in the name of the mullahs, their families, and agents by order of "Wali Faqih" (Supreme Leader) according to Article 5 of the constitution, which gives absolute power to the Leader.

During the eight-year war with Saddam Hussein and other proxy wars, enemies of Iran killed over a million Iranian youths as a result of the Wali Faqih decree in Article 5 of the Constitution. Most Iranian people have stated and written that with Article 5, there is no need for a constitution because the Supreme Leader has the absolute power to do anything and everything with no limit to his authority!

The grand policy of the country is under the command of the jurist: declare war, execution, imprisonment, torture, suppression of the press, elections, and the withdrawal of incredible amounts of currency, all with the control and permission of the Supreme Leader according to Article 5 of the Constitution.

Today, the issue of the Woman Life Freedom revolution, which the hijab is a significant part of, has its roots in Article 5 of Velayat Faghih of the jurist, which in Iran is called (Bring Fire) and the executors of the orders of the jurisprudence, according to Article 8th of the constitution, which is called (the order of good behavior).

According to Article 8, they suppress, throw acid on girls' faces, poison female students in schools, and dozens of other criminal acts.

For the past 45 years, the youth of Iran should know that Poverty, Misery, and Crisis are the three factors that have kept the Mullahs' regime in power in Iran.

Over 60% of Iran's population lives below the poverty line. Hence, the Poverty and Misery of the people are the Mullahs' benefactors who do not allow anyone to get rich except

themselves. People's poverty to the point of selling their body parts and the need for subsidies and relying on government rights are the ideals of Mullahs who can steal more easily.

The scourge of state drug addiction and religious prostitution (Sigheh) has become sources of regime income.

The Mullahs' regime favors the US sanctions for two reasons:

1- to blame the poverty and misery of the people on the US sanctions,

2—To bypass the sanctions, they import American goods and services from third countries, sell them at many times more than the original price, and deposit the profits in the banks of the West and the East in the name of Mullahs and their families.

The third factor of the regime's survival is generating the Crisis that the Mullahs have created in the region in the past 45 years.

The Military Industries Complex of the West and the East are interested in keeping the Mullahs in power. For this reason, the Western and Eastern governments prospered economically by selling arms.

The looting of Iran by the mullahs and putting all the stolen money in foreign banks is another guarantee of support from the West and the East to keep the mullahs in Iran.

For example, one of the thousands of mullahs' thefts is the remittance of 3 billion Dollars to Canada by Khavari, a close relative of Ayatollah Khamenei, at which the Canadian government issued a certificate of appreciation to this well-known Islamic Republic of Iran thief.

Inside Iran, the Woman Life Freedom Revolution is alive and well, will never stop, and will continue despite the oppression by the Mullah's regime.

Outside of Iran, educated Iranians publish the current news inside Iran quite well and with good intentions, using the Internet to tell the youth about Iran's proud history.

There is not a day that groups, associations, congresses, parties,

and groups of Iranians living abroad do not gather and demand the overthrow of the mullahs in Iran with petitions, announcements, and statements!

But these discourses do not even touch the robes of the mullahs in Iran. Despite all the anti-human violations of the Mullahs regime, somehow, the prestigious chairmanship of the human rights committee in the United Nations is chosen by an appointee of the Islamic Republic of Iran.

No powerful government in the World, and none of Iran's neighboring countries, especially the Arabs, can or want to change the Mullahs regime in Iran.

Even Israel, the so-called main enemy of Iran's Mullahs regime, according to Mr. Netanyahu, the Mullahs' regime has brought Israel closer to the Arabs, Israel's sworn enemy.

Today, no discussion other than "Changing the Constitution of the Islamic Republic" is a solution to save Iran.

No government in the World except the United States, which has all the banks under its control due to SWIFT and the strength of the Dollar, can change Iran.

At first glance, many experts argue that America cannot change the Constitution of another country.

However, in 1979, the Mullahs wrote the Constitution of the Islamic Republic, which includes eight instances to fight against America and the defeat of America after forty-two years, establishing an Islamic World Government and creating international terrorism and enmity with America and her allies and fight with the American interests anywhere in the World. America can object to the eight instances in the IRI's Constitution, and protests in the US Senate would ultimately echo the "Woman Life Freedom" revolution, which is related to other items in the Constitution.

American historians should know that the power of the Ayatollah's regime resides in international terrorism. The fight against American interests is not only through its proxies, e.g.,

Hezbollah, Hamas, Yemeni Houthis, etc., but also the sleeping cells, with billions of Dollars, by the approval of “Wali e Faghih,” thousands of believers in “Wilayat Faghih,” the wealthy immigrants of the IRI regime have created all over the World, even in the United States.

To save Iran, we, the Americans and the Iranian Americans, have suggested to the US Senators in our states to review the eight instances in the Islamic Republic of Iran's Constitution.

Cyrus Force Typical Letter to the US Senators

Dear Senator xxxxxxxx,

We, the Iranian Americans of Cyrus Force, left our birth country, Iran, due to a Constitution that was imposed upon our countrymen and women by the Ayatollahs. We now find that we must have the privilege of bringing this to your attention today and asking for a voice in the Senate. We believe that bringing this to your attention is the only manner in which Iranian Americans can facilitate the downfall of the repressive and murderous regime of the Ayatollahs with the help of the American government. Please bear with us as we explain.

Israel is, to quote President Reagan, “the strategic treasure of the United States”; it is also the only democracy in the Middle East.

2. The second is the balance of power, human rights, and freedoms of the peoples of the Middle East.

In light of these two all-consuming global issues, let us look at the two ideologies of Wahhabism all over the World and Shia Iran, which are imminent threats to Israel. It would indeed be a long discussion to argue which one is worse for Israel.

However, it has been argued and proved in the book "Imagine! The Fall of the Ayatollah's Constitution", that full recognition of Israel by Saudi Arabia will eliminate both threats to Israel forever. The beginning chapters of the book describe the intent of the Wahabi, Suni, and Shia sects of Islam. 2. Article 11- Institution of Jihad and Islamic custom
3. Article 14- Retribution of non-respect and Jihad
4. Article 57- The governing powers in Iran, the legislative, the executive, and the judiciary powers, operate under the supervision and absolute authority of the religious leadership of “the community of believers,” the Islamic Republic
5. Article 60—The executive powers are exercised by the President of the Republic and his ministers, except in matters directly related to the leadership in Article 57, Meaning that the Supreme Ayatollah Leader exercises all law.
6. Article 144- The Army of the Islamic Republic of Iran must be an Islamic army, committed to the Ideology of Islam, with individuals who are faithful to and devoted to the goals of the Islamic revolution.
7. Article 151- This is a call to arms for the people to fight against all who do not believe in their religious ideals.
8. Article 154- Supports the struggle of the oppressed for their right to get rid of the oppressor anywhere in the world, called Jihad.

As you can see, the Constitution is directly influential in creating chaos and hatred in the world of non-Islamist, and therefore, changing the Constitution is the first step in normalizing and creating a democracy for all the inhabitants of Iran who desperately want this democracy and normalization.

Today, we, as Iranian Americans, are writing to you, our Senators, emphasizing the key to the removal of the Ayatollahs

The US intelligence agencies know, and Henry Kissinger wrote: "A democratic regime in Iran makes this nation the most natural ally of the United States of America."





Cyrus Force Typical Letter to the President

Dear Mr. President,

Greetings

After 45 years of being trapped in poverty, misery, and crisis, Iranians concluded and know very well that the regime of the Ayatollahs in Iran favors Bilderberg meeting, British Freemasons, Military-Industrial Complex, the US Allies, even US adversaries Russia, China, and Iran's neighboring countries. First - some principles of the Constitution of the Islamic Republic show that the regime should be hostile to the US and that the proxies of the regime should be scattered around the world to fight for American interests wherever they are.

Second - some parts of the Quran Chronicle show that the regime of Ayatollahs, as they say, does not believe in the completeness of the Quran.

The purpose of publishing this book is to pay tribute to the heroes of the Revolution, "Woman Life Freedom," and to show the betrayal of a small number of Iranians abroad who the Western State Media supports.

If one day after the recognition of Israel by Saudi Arabia or before that, it is decided that the regime of the Ayatollahs should change their behavior, then the only leverage of American pressure is to call the regime's anti-American and terrorist principles and seek interference in the Constitution of the Islamic

Republic and “Smart Sanctions” on the regime thieves and looters of Iran (Oligarchies of Ayatollahs).

There are a few Articles of the Islamic Republic of Iran Constitution for the US Administration to consider.

The Islamic Republic of Iran Constitution, including its nine-page introduction, is 12,000 Words.

With the separation of religion from Government in the same Constitution, it becomes 9500 words.

For English readers, from the exact translation of the Constitution, sentences that should cause concern are copied and pasted here:

The catalyst for the nation’s united movement was Imam Khomeini’s objection to an American scheme, “the White Revolution,” which was a step toward strengthening the foundations of tyranny and increasing Iran’s political, cultural, and economic dependency on world imperialism.

Despite Imam Khomeini's exile from Iran because of his objections to the outrageous capitulation law (which ensured American advisers’ legal immunity), the firm ties between the Muslim community and the Imam remained intact.

An Ideological Army

In establishing and equipping the country's defense forces, the focus shall be on maintaining ideology and faith as the foundation and measure. Consequently, the objective forms the Army of the Islamic Republic and the Islamic Pasdaran Revolutionary Corps. They will undertake the responsibility of not only guarding and protecting the borders but also the weight of ideological mission, i.e., striving (jihad) on the path of God and struggling to expand the sovereignty of the law of God in the world.

The Mullahs wrote the Constitution with the hope that this would be the century of the universal rule of the oppressed and the defeat of all the oppressors.

Article 11:

According to the Qur’an, “Verily, this brotherhood of yours is a

single brotherhood. And I am your Lord and cherisher: therefore, serve me” (21: 92). All Muslims form a single nation. The government of the Islamic Republic of Iran is required to base its overall politics on the merging and unity of the Muslim countries. It must continuously strive to achieve the Muslim world's political, economic, and cultural unity.

Article 14:

According to the Qur’an: “Allah forbids you not, about those who fight you not for (your) faith nor drive you out of your homes, from dealing kindly and justly with them. For Allah loveth those who are just” (80: 8), the government of the Islamic Republic of Iran and Muslims are required to treat the non-Muslim individuals with good conduct, in fairness and Islamic justice, and must respect their human rights. This principle is valid for those persons who have not conspired or acted against Islam and the Islamic Republic of Iran.

Article 57:

The governing powers in the Islamic Republic of Iran consist of the legislative, executive, and judiciary powers. According to the forthcoming articles of this law, they operate under the supervision of the absolute authority of the command (Vali e Faghih) and religious Leadership (Imamat) of the community of believers. These powers are independent of one another.

Article 60:

The executive power is exercised by the President of the Republic and the ministers, except in affairs directly delegated to the Leadership by this law.

Article 144:

The Army of the Islamic Republic of Iran must be an Islamic Army, i.e., committed to Islamic ideology and the people. It must accept into its service deserving individuals who are accurate to the goals of the Islamic Revolution and devoted to realizing them.

Article 151:

Under the venerable Qur'anic verse, "Mustering against them all the men and cavalry at your command, so that you may strike terror into the enemy of God and your enemy and others beside them who are unknown to you but known to God" (8: 59),

Article 154:

The Islamic Republic of Iran considers human happiness throughout human society as its ideal.

It considers independence, freedom, and the governance of justice and truth as the rights of all the world's people.

Consequently, while it completely abstains from any intervention in the internal affairs of other nations, it supports the struggles of the oppressed for their rights against the oppressors anywhere in the world.

Chapter two

Cyrus Force's Campaign in the West; A Call to Action:

Friends and foes need to understand Cyrus Force's mission, and we write it in different ways:

Cyrus Force's purpose in publishing this book, which content randomly has been sent to American and European Politician is to bring the following messages from many Iranians to the attention of the American and European people:

1- Iranian people and even Western administrations were deceived by an unknown Ayatollah Khomeini from April 1978 until April 1979 by believing his speeches about democracy and maintaining friendly relations with the West.

2— After the referendum of April 1979 and solidifying the Islamic Republic Government in Iran, he started showing the true nature of his mindset when the Assembly of Ayatollahs wrote the Islamic Republic Constitution. Article 5 (Velayat e Faghih), which gave him absolute power, was opposed by many, even the most popular and kind Ayatollah Taleghani. On September 16, 1979, the Mullahs killed him in a mysterious death, and on September 19, the Mullahs wrote Article 5 in the Constitution.

3— Inside Iran, many things happened, which were not Western concerns, but taking Americans hostage at the US Embassy and the Iraq war was the direct consequence of the Islamic Constitution of Iran with Ayatollah's consent.

4— From the Autumn of 1979, every misdeed of the Iranian Government has been according to its constitution.

5— Three issues have kept the Ayatollah's Regime in power: Poverty, Misery, and Crisis. These have made the lives of most Iranians unbearable, but they are welcome and a good source of income for the West and East.

6— The crisis in the Middle East has had two benefits: 1- boosting the arms race and 2- bringing Arab Governments closer to Israel.

7— The most crucial brunch of the Crisis is International Terrorism against America and American Interests anywhere in the world, as indicated in 8 places in the Iranian Constitution.

8— Until October 7, 2023, any act of Terrorism by the Ayatollah's regime could have been considered collateral damage. But this should be a wake-up call that Ayatollahs, for the last forty-five years, have planted their Terrorist

Sleeping Cells around the World with Billions of Dollars in wealth. In the future, when Artificial intelligence is for sale, it can bring more harm to the US than 911. God forbid!

9— America must be aware of the pro-terrorist sentences in the Ayatollah's Constitution.

10— The present form of sanctions is hearting the Iranian Population and helping Ayatollahs to loot Iran, with the excuse of going around sanctions and depositing their stolen assets in the Western Banks.

11—In Cyrus Force organization, we believe if the US Admiration starts a narrative about the Ayatollahs' Constitution and imposes Smart Sanctions on the cronies of Ayatollahs who have billions of Dollars of wealth in the West, it will cause a domino effect on the “Woman Life Freedom” revolution inside Iran and boost their demand for the change of Article 5 and Article 8, which are the core of this ongoing revolution in Iran.

12— We at Cyrus Force are preparing for the next stage of our campaign, which will be inside Iran, and it does not need any help or interference from outside the borders of Iran.

Chapter Three

Cyrus Force Campaign inside Iran

The Cyrus Force has the tools and know-how inside Iran to enlighten people about changing the Islamic Constitution of Ayatollahs.

1- The Holy Book Quran

Inside Iran, a Change in the Constitution must happen because the current rules and regulations of this Regime are not according to the teachings of the Quran.

To prove to the masses of people from whom they get their orders and guidance from Ayatollahs, reading the Quran in Persian and chronic (Quran e Rastan) is recommended. Sohrab Chamanara published a version of the Quran called “Quran e Rastan,” meaning True Quran.

In the Quran, four crimes have punishment: 1- Killing, 2- Stealing, 3- Armed rebellion against the Islamic Government, and 4- Adultery with four witnesses.

There is no punishment for writing or talking about the wrongdoing of the Islamic Government and Leader or for demonstrating against the Leader and Government.

There is no punishment for women not having a “Hijab” or headdress.

There is no punishment for drinking wine or spirit.

There is no punishment for being a nonbeliever. The Quran encourages Muslims to guide the nonbelievers and, if they do not believe in God, recommends leaving them alone, as God will punish them after death.

For a simple reason, an intelligent person with a little bit of common sense understands that the Islamic Republic of Iran Constitution is NOT in harmony with the teachings of the Quran, and the people should write a new Constitution.

However, the actual reason is to read the Quran correctly,

chronically, and in one's native language.

Ten years after the death of Prophet Mohammad (S) during the khalifate of Osman, a group of Islamic believers changed the chapters of the Quran (Surah), and the Khalif ordered that the people of Iran (Persian Empire) read the Quran in Arabic without knowing its meaning. Hence, the decision became a Tradition (Sunah) of Islam to read the Quran without knowing its meaning. Furthermore, only religious leaders and scholars can interpret and explain the meaning of the verses. This stupid tradition made the religious scholars cherry-pick verses, either saying the Quran is a book of peace and kindness or saying the Quran is a book of killing and terror.

Suppose the Quran is read chronically and in a person's native language. In that case, one will see the biography of 23 years of the life of the Prophet in the Quran, where the first half of the Quran was written in ten years in Makah when the Prophet was married to Holly Khadijah, who was a Jewish Hanif (The Jews who believe in Ebrahim only) and the second half of the Quran written in thirteen years in Madinah when Salman the Persian (an Iranian Mazdakite fugitive) was an advisor and strategist of the prophet.

Fourteen centuries ago, an ideology like Communism rose in the Persian Empire, and King Qobad became Mazdakite. But his Crown Prince Anu-Shirvan, with the support of Zoroastrian clergies, massacred all Mazdakites and their leaders. Salman Farsi, a Mazdakite Scholar, ran away and took refuge among the Jews in Madinah.

When Prophet Mohamad (S) lost his supporters in Makah, his wife, and his uncle, he immigrated to Madinah because his book (the first half of the Quran) was based on stories from the Bible and praised Jews as "Chosen People." The Jewish tribes of Madinah welcomed him and supported him.

Very soon, Salman found a plan to revenge the Iranian Kingdom and Zoroastrians. For thirteen years, he staged twenty-seven wars, during which Salman succeeded in bringing the entire

Arabia under the flag of Islam.

During these thirteen years, Salman sent the Book of Makah to his friends and the Iranian Army, who were fed up with Zoroastrian clergies and King injustice. He gave them the good news of the coming Messiah, who would free Iran.

Just like Khomeini in 1979, who promised good things, when they took control of the Nation, they showed their true face, and the law of the land became Madinah verses.

During the prophecy and writing of the Quran, Mohammad (S)'s followers asked to perform a miracle, as Mosa and Jesus did. He always replied that he was a man like you, and his only miracle was the Quran, which Allah revealed to him through Gabriel. I am only the messenger of Allah (Rasool o Allah).

Therefore, the Quran should be read chronically so that every verse coincides with the date and condition of the time it was written.

For example, the word Jihad is mentioned in the book's first half (Maki Verses) with the meaning of "Strive." However, this word appears forty times in the second half (Madani verses), meaning fighting and killing infidels.

Therefore, if the Quran is read chronically and in Persian, Iranians will find out the Constitution is not in harmony with the Quran.

However, our reasons for rejecting the Constitution are another important belief of Ayatollahs.

The majority of Shia Ayatollahs believe the Quran is in two volumes. We have the first volume, and the 12th Imam will bring the second volume. Many Ayatollahs have said this, and Ayatollah Kamal Heydari can be searched on the Internet and listened to his sermons.

The Ayatollahs believe that since the Quran is not complete, we must find our guidance from Hadis (Hadis are Islamic stories quoted from prophets and Imam hundreds of years after their death).

Consequently, the Islamic Republic Constitution is not in

harmony with the Quran and is based on Hadis.

2- **Shahnameh (Epic of the Kings)**

When the Persian Empire fell 1400 years ago, books and libraries were burned, and people were ordered to read only the Quran.

Iranians had no recollection of the past or any reference except the books of the Torah, which, after the Book of Ezra and the Coming of Cyrus the Great, allowed them to read the history of Iran in the Torah.

Four hundred years after the fall of the Persian Empire, Ferdowsi spent all his life collecting information and writing Shahnameh, including 50,000 poems covering the beginning of creation, the Solar System, and the earth up to the defeat of the Persian Empire.

The book is recognized as a masterpiece by many non-Iranian and every Iranian scholar.

Shahnameh is a forbidden book of Ayatollahs but is most popular among Iranians, and some regard it as the Holy Book of Iran.

Shahnameh has been summarized in 300 pages, written both in poem and text, including all the stories. It has been circulated underground in Iran and is available for free download by Cyrus Force.

3- **Cyrus Cylinder**

The best description of Cyrus Cylinder is conveyed by the president of the British Museum, where the Cylinder is kept after its discovery in Iraq 100 years ago. Speech could be heard in YouTube.

The message is simple, and it is the first document of the Iranian Constitution at 2500 years ago.

Magna Carta is the first document of the British Constitution 800 years ago.

After Cyrus Cylinder was written, there were many kings managing the Empire of Iran, with borders from China to Mediterranean. Their success was to obey what was written in the Cylinder.

Cyrus Cylinder should be the Iranian Slogan for the future constitution.

4- **Three Commandments of Zoroaster**

Nobody knows the birth date of the Zoroaster philosophy in Iran and when the book of “Gadha” was written.

Even there is a dispute about the place of Zoroaster, who never claimed to be a prophet but a teacher.

Zoroaster conveys a simple message of the three commandments: Good Thoughts - Good Deeds - Good Words.

Contrary to the fact that Zoroaster’s is a philosophy, they say this is the oldest and mother of all religions.

Many experts believe that the Aryan Tribes, who immigrated from the North to the South due to cold weather, went to India, and some to the Plateau of Iran, and called themselves Aryan.

Historians used the word Iran from Aryan.

These people found cities in this newly discovered land dated 10,000 years ago, living with Zoroastrian philosophy, and that was the law of these Iranians for many millenniums to come.

The first Iranian Government was formed in Ilam 4,000 years ago, with its capital in Susa (Shoosh). One hundred (100) years ago, Archaeologists discovered 300 Articles of the Hammurabi Constitution in Susa.

Three thousand (3,000) years ago, another Iranian Tribe formed the Government of Med (the Iranian Kurds and Azerbaijan) while the Greek Empire was in power.

Two thousand five (2,500) hundred years ago, another Iranian Tribe formed the Government of Persia (the Persian) while the Roman Empire was in power.

There has never been any fight between Iranian Tribes, and all transfer of power has been peaceful among families since religion has no part in the Government and there was no religion except Zoroastrian and Judaism.

The conflict in the Persian Empire started when Constantine united the East and West Romans, and the Vatican became the center of power on Iran's Western borders.

To counter the Romans' religious power, Zoroaster Clergies started interfering with and influencing the Government, and gradually, their power became equal to that of the kings.

The Mazdakite disaster was the start of the Collapse of the Empire, and their commandments were replaced with the Sharia Laws of Zoroastrian Clergies and made Iran ready for collapse.

Iran needs a constitution that separates religion from Government, and the writers of the new constitution should have in mind Zoroaster's three commandments.

Conclusion

We, the Cyrus Force (Followers of Cyrus), believe there is no other way to change the behavior of the Ayatollahs' Regime in Iran except changing its constitution.
